# HOOKSETT CALENDAR COMMITTEE MEETING NOVEMBER 4th @ 4pm HMS

The results of the survey were reviewed. See below. The percents on the questions that people could choose more than one answer were not correct.

Based on actual responses (375) the holiday question in percents is as follows:

Columbus day: 49% were in support of having school

Civil Rights day: 53% Presidents Day: 59%

The Wednesday before Thanksgiving: 46%

Maryann B pointed out during the discussion that in K there are 9 days lost to NWEA and other testing. The days is not as high in Middle school. This wa sin response to discussion of one comment from a parent stating kids dont really get into "learrning new information" until Oct.

Committee agrees based on results:

- -1/2 day the Wed before Thanksgiving
- -Presidents day should be school day
- -Civil rights should be school day

In regards to Staff and Early release days: Most were in favor of FULL PD would like Collaboration Time! On going learning-

Suggestion: more SAU wide PD to Columbus Day

Front loading PD: not just workshops

- 1. set up day
- 2. all school meeting
- 3. training/kids meeting teachers

Other days:

- 4. conferences
- 5. last day--not as helpful at end of school
- 6. Sept

Teachers on committee agree they wanted one in spring. March? Sept was good but not as helpful since school year just started.

Committee agrees to add day in March. Although we want to reduce sdays spent in June more important to train our teachers so that the time spent with kids means more! Better teacher=better learning!

Lindsey will forward calendar that includes dates discussed. Committee understand exact days may be moved based on term endings...ie: March PD day.

Committee wants to use this as a "transition" calendar to allow more time to develop a calendar based on hours. However with limited time to gather infor from parents/teachers and deadline of Dec 1 there was not time to

develop a calendar. This 2014-15 calendar incorportates many "wishes" and allows time to develop a good working calendar for ongoing years.


