Cawley ESOL Position

Overview: English Language Learners are prescribed a required amount of services per federal guidelines and state recommendation. The prescription of services is based upon student performance on the yearly language acquisition assessment, ACCESS. There has been an unexpected increase of services needed for students at Cawley Middle School due to students moving in that are in need of at least 2 hours a day of specialized instruction. We are proposing an increase of teaching time at Cawley to meet this need.

1. To increase the teaching time for the ESOL teacher from 0.5 FTE to 0.9 FTE
2. To utilize the funding from the Read 180 Teacher Vacancy (retirement June 2017)
 - a. The Reading Specialist will now provide intervention in language arts classes and with small group or individual instruction in her classroom, reducing the need for filling the Read 180 vacancy.
